Will of Isaac Lusitano de Pina. London, 17 October 1763. The National Archives, Public Record Office, PROB 11/883/158

In the Name of God Amen. I, Isaac Lusitano de Pinna of London, surgeon, being of sound and perfect mind, memory and understanding do make my last will and testament in manner and form following, that is to say, I give, devise and bequeath one full part or share of what estate and effects I shall leave behind me at the time of my death (after the payment of my just debts, funeral expence and the charges of proving this my last will) to be disposed of and applied to charitables uses at the discretion of my executrix hereinafter name, and after such disposition and application of such ten part, I do give, devise and bequeath all and singular the rest residue and remainder of my goods, chattels, debts, credits, ready money, rights and estate real and personal whatsoever and wheresoever that I am now possessed of interested in or in any ways entitles unto, or that at time of my death I may or shall be possessed of interested in or in any ways entitled unto, to my very good and well beloved wife Saharah de Pinna, to hold to herself, her heirs, executors, administrators and assigns forever, and I do hereby nominate, contitute and appoint my said wife sole executrix of this my last will and testament, and I do hereby revoke all former wills by me at any time heretofore made, and I do declare this only to be and contain my last will and testament. In witness whereof I have hereunto set my hand and seal this 17 day of October in the year 1744. Isaac Lusitano de Pinna signed, sealed, published and declare by the said Isaac Lusitano de Pinna, the testator, as and for his last will and testament, in the presence of us, who in his presente and at his request and also in the presence of each other have hereunto subscribed our names as witness.

3.d January 1763

On which day, appeared personally Abraham de Paz, of the parish of Saint Botolph, Bishopgate, London, gentleman, and David Taboada, of the parish of Saint James Dukes Place, London, apothecary, who jointly and severall made oath on the Pentateuch or five Books of Moses, as followeth, to wit that they have respectively known and been well acquainted with Isaac Lusitano de Pinna, late of the parish of Saint James Dukes Place, London, deceased, for several years before his death and have, during such time, often seen him write and subscribe his name and were and are thereby become well acquainted with his manner and character of handwriting and subscription, and these deponents having now sees and carefully perused the paper writing hereunto annexed purporting to be the last will and testament of the said deceased bearing date the 17th day of October in the year 1744, they, these deponents, do upon their oaths severally swear and depose that they do vereily and in the their consciences believe the whole contents of the said will and the signature thereto subscriber to be entirely written by and with the proper hand of the said Isaac Lusitano de Pinna, the testator, deceased. Abraham de Paz. David Taboada - The same say the said Abraham de Paz and Davod Taboada were duly sworn before me -And. Coltee Ducarel, surrogate – present before Rob. Bargrave, not. ry publ.

This will was proved at London on the twelfth day of January in the year of our Lord one thousand seven hundred and sixty three, before the worshipful Andree Coltee Ducarel, doctor of Laws and surrogate of the right worshipful Sir Edward Simpson, knight, also doctor of Laws, master keeper or commissary of the Prerrogative Court of Canterbury, lawfully constituted by the oath of Sarah, otherwise Saharah de Pinna, widow, the relict of the said deceased and sole executrix names in the said will, to whom administration of all and singular the goods, chattels and credits of the said deceased was granted, she having been first sworn duly to administer.
